# Countess Markievicz Scholarship in Female Leadership

# Theme Information

This scholarship is offered by the Department of Business, Enterprise and Innovation (DBEI) in partnership with the Irish Research Council and the Department of Justice and Equality (DJE).

### INTRODUCTION

The scholarship was first announced by the Department of Business, Enterprise and Innovation (DBEI) at the <u>Countess Markievicz Conference: Celebrating Women Leaders in</u> <u>Ireland</u> in November 2019. In advance of the Conference, DBEI commissioned a Behaviour and Attitudes survey among 5<sup>th</sup> year female students, focusing on their ambitions, aspirations and interest in leadership roles, with a focus on politics and public service. The <u>findings of this</u> <u>survey</u> will inform the research by the successful applicant and will inform future policy in the area of women in politics and business.

Further to this Conference, and in celebration of the life and legacy of Countess Markievicz, applications to the **Countess Markievicz Scholarship in Women's Leadership** are now invited.

The scholarship has the aim of assisting the development of national policies to increase the participation of women in senior leadership roles. Specifically, this new scholarship will focus on the themes of "Women in Business" and/or "Women in Politics and Public Life". Policy context is as follows:

Increasing the proportion of women in senior management and at board level of Irish companies and increasing the proportion of women in leadership roles in Irish politics are key policy priorities in Ireland.

This scholarship will fund a postgraduate researcher to undertake cutting-edge doctoral research in line with either of these policy priorities.

The successful applicant will be hosted and mentored by DJE. With the guidance of an **expert advisory group**, led by DBEI and DJE, the award holder will formulate an evidence base that supports the development of policy to achieve either or both of the **national policy priorities** outlined above. This is a unique opportunity for a researcher to benefit from guidance and mentorship from key policymakers, gender-equality experts and business leaders.

Applications to conduct research within the context of the <u>Decade of Centenaries</u> programme and that consider the impacts and legacies of that decade (1912-1923) on the policy priorities of DBEI, from a gender-equality perspective, are particularly welcome.

#### PROPOSAL REQUIREMENTS

- Applications must seek to aid the development of innovative national policies and practises to support the next generation of women leaders.
- Applicants must show how their proposed research furthers the DBEI and DJE policy priorities outlined above.
- The successful applicant will work with an Expert Advisory Group, nominated by DBEI.
- The funded proposal must consist of a new PhD proposal and must be completed within 36 months.
- Progress reports will be shared with DBEI, DJE and with the Expert Advisory Group.
- The successful applicant will be based primarily at DJE (Dublin 2).
