#### 1. HELP WITH TECHNICAL ISSUES

- This document is provided to assist you in submitting an Enterprise Mentor reference form for applications under the 2024 Enterprise Scheme Programme. Please read it carefully before submitting your reference form online. The Irish Research Council will only accept reference forms submitted through the online application system. Please do not send your reference form to the Council by email or in hard copy.
- Please ensure that the email address <u>ircapps@research.ie</u> is on your 'safe senders' list.
   You may need to check with your IT department to ensure there is no issue with your organisation's internal firewall.
- If you experience any technical issues, please clear the cache in your browser and continue. If the issue persists, please contact <a href="mailto:system@research.ie">system@research.ie</a>. Where possible, please include:
  - the Smart Simple project ID of the application,
  - the browser you are using
  - and, if appropriate, a screenshot of any error messages.
- The grants management system is only compatible with the two most recent versions of Firefox, Chrome, Internet Explorer and Safari.

### 2. LOGGING INTO THE ONLINE SYSTEM

The content of this guide is for general information purposes only. 
- When initially registered, you should have received an email containing your username (which is your email address), password, and a link to the <u>login page</u>. If you are not yet registered on the online system, please have the applicant send you and your company an invitation to register.
- If you have lost or forgotten your password, navigate to the <u>login page above</u> and click 'forgot password?'. A system-generated password will be forwarded to your email address. If you do not receive this email, please check your spam folder. Please note that it may take up to 15 minutes to receive the email containing your new password.
- You will not be able to create and submit your Enterprise Mentor form until the applicant has submitted their application.
- Details of the application can be previewed while it is in draft status by selecting 'Draft Applications Assigned' and then clicking on the PDF button under 'View Application PDF'.

#### 3. CREATING AND EDITING YOUR ENTERPRISE PARTNER FORM


 Once the applicant has submitted their application, you should receive an automated email asking you to log in and submit your Enterprise Partner form. Click on the 'Activity Pending Action' icon on the home page in order to view any applications awaiting your reference.

• If you wish to view the application as it was submitted, please click on the 'View application PDF' button.


#### **Activities Pending Action**



- Once you have clicked the 'Open' icon, the reference form will open in edit mode. You
  can then complete your reference. This reference is an essential element of the
  application, and all sections should be completed in full. The information you have
  entered can be saved at any time by clicking on the 'save draft' button at the bottom of
  the screen. Please do not navigate to any other tab or browser until all the information
  you have entered has been saved.
- The Irish Research Council maintains 'gender-blinding' of applications for evaluation purposes to mitigate any gender bias in the assessment of excellence. As such, our assessors review applications that are anonymous and free from pronouns or other words which would identify the applicant's gender. In order to comply with these guidelines, we ask that you use 'the applicant', 's/he' and 'his/her' when providing your observations rather than the person's name or pronouns which would identify their gender.
- Enterprise Partners can access and edit their forms as often as necessary prior to submission by logging into the 'Activities Pending Action' icon on the online system.

#### 4. SUBMITTING YOUR ENTERPRISE PARTNER FORM
